As the summer activity slows down, the legislative work speeds up. There is a new possibility on the horizon. Remember how Washtenaw County was able to

pass a mileage that generated revenue for veterans' benefits and for operating the Washtenaw County Department of Veterans Affairs? As a result, Washtenaw is now even able to provide some assistance to veterans who have not been deployed. There were other benefits, as well, of course. Well, there is a potential source of revenue that could do the same thing for the State of Michigan. Imagine one source of revenue that would come in every year that would fund the Michigan Department of Veterans Affairs, take care of burial and other veterans' benefits, get county veterans services offices up and running in every county, operate the veteran homes for disabled veterans and so forth. Now imagine that this source would be tax free!

Not long ago, the United States



Supreme Court ruled that the US law that banned sports gambling except in Nevada was unconstitutional. That means that all states may now have sports gambling programs, including video gambling, and may receive appropriate revenue from money spent gambling, much as the State now receives money from Lottery gamblers. Shouldn't some of the new money from sports gambling pay for support of veterans'

programs statewide?

If you think the answer is "yes," now is the time to do something about it. All you need to do is call your local state legislators and tell them why you think it is important that they use the sports gambling revenue to support veterans first. I assure you that if you contact your legislators and give them a good reason to support veterans, your message will be taken in to consideration. There will be competition for these funds, so, numbers will matter. Not only will the legislature need to have good reasons to use the funds to support veterans, but they will need to know that there is fundamental support throughout the community for this idea.

The other thing to do is to ask your friends and family to do the same thing. Help make your voice and their voices mean more to the legislature than the voice of the lobbyists.

Remembering KIA Anniversary September

Lance Corporal **Hermon Eugene Fuller, Jr.** was born on March 9, 1947 in Ypsilanti, Michigan to Mr. Hermon E. and Mrs. Eugenia Fuller of Ypsilanti. Hermon was a 1965 graduate of Ypsilanti High School where he ran cross country and played football.

He gained a nickname in High School of "Flea" because there was a flea on the Soupy Sales Show named Herman. He also was a member of the Boy Scouts, and he worked on the stage crew for High School plays.

Lance Corporal Fuller enlisted in the Marine Corps on July 27, 1965 and received his infantry training at Camp Pendleton, California. Hermon was stationed in Okinawa before being deployed to Quang Tri Province, South Vietnam serving as a rifleman



with G Company, 2nd Battalion, 7th Marines, 1st Marine Division, III Marine Amphibious Forces. He died on September

25, 1966 as a result of multiple fragmentation wounds from a mortar attack.

Hermon Eugene Fuller, Jr. is survived by his parents, a brother and three sisters. He lived 19 years, 6 months and 16 days. Hermon's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 11E Line 014.

Hospital Corpsman Third Class **Gary Robert Shepperdson** was born on July 13, 1946 to Mr. John and Mrs. Margaret Shepperdson of Ann Arbor, Michigan. Gary was

a 1965 graduate of St. Thomas High School in Ann Arbor. He also attended Eastern Michigan University before enlisting in the Navy in September of 1966.

Hospital Corpsman Third Class Shepperdson began his tour of duty in Quang Nam Province, South Vietnam on July 10, 1968 serving as a Hospital Corpsman with Headquarters and Service Company, 2nd Battalion, III Marine Amphibious Forces. Gary was killed on September 30, 1968 as a result of a gunshot wound



from enemy rifle fire while participating in Operation Mameluke Thrust.

Gary Robert Shepperdson is survived by his mother, a sister

and three brothers. His father preceded him in death in 1957. He lived 22 years, 3 months and 17 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Gary's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 42W Line 050

Hospital Corpsman Third Class **Scott Philip Smith** was born on May 30, 1947 in Ann Arbor to Mr. Philip H. of Grass Lake, Michigan and Mrs. Ralph (Jeane) Foreman, Jr. of Northville, Michigan. Scott was a 1965 graduate of Chelsea High School where he was on the

track team and the High School Band. He also attended Grand Valley Junior College in Grand Rapids, Michigan before he entered the Navy on March 17, 1967.

Hospital Corpsman Third Class Smith began his tour of duty in Quang Tri Province, South Vietnam on June 3, 1969



serving as a Corpsman with Headquarters and Service Company, 3rd Battalion, III Marine Amphibious Forces. Scott was killed on September 17,

1969 as a result of an explosive device.

Scott Phillip Smith is survived by his parents, a half-brother and a half-sister. He lived 22 years, 3 months and 17 days. Scott's name is listed on the Vietnam Memorial in Ypsilanti Township under Chelsea. His name also appears on the Vietnam Memorial in Washington, DC on Panel 18W Line 106.

The Vietnam War: Why Were We There?

In January 1965, Pres. Lyndon B. Johnson gave a State of the Union speech to Congress, in which he explained to Congress members "why we were there," namely, in Vietnam. Other Vietnam War experts can tell us



what we did in Vietnam or what we should have done in Vietnam. But as for me, my preference is to explore the question as to why

we were there.

Actually, Pres. Johnson himself gave us what I think is the best answer to that question, as follows:



“Twice in one generation we have had to fight against aggression in the Far East. To ignore aggression now would only increase the danger of a much larger war. Our goal is peace in Southeast Asia. That will come only when aggressors leave their neighbors in peace. What is at stake is the cause of freedom, and in that cause, America will never be found wanting” (Pres. Lyndon Johnson, <https://www.youtube.com/watch?v=uou8EppdfAM>, minutes 13-15, January 4, 1965). Herein lies the entire meaning of the Vietnam War—succinctly explained in just a few words, which Pres. Johnson knew very well how to do. Averting “the danger of a much larger war”—that was the meaning of the Vietnam War. In that sense, the Vietnam War was a difficult and different war, because the objective of it was difficult to assess. Most wars have a clear

objective, which one can either fulfill or fail to fulfill—but the result is clear and easy to assess. But in the case of the Vietnam War, victory was not the object of it. Averting a “much larger war” was the object of it. And this is something one can know with a certain degree of certainty only decades after the war’s end. So, for years now, I have been saying that only in our time, that is, about 40+ years after U.S. troops pulled out of Vietnam (1973), can we have a degree of certainty whether that war was successful or not. And the correct question about the success of the Vietnam War is this: Did the Vietnam War avert the danger of a much larger war? That “much larger war” was a war against the Communist forces in the 1960s-70s, against the combined Communist front involving China, the Soviet Union, Vietnam, Cuba, and North Korea,

with a possible assistance of Iran.

In conclusion, since this “larger war,” thank God, has not happened, one can say that the Vietnam War, yes, fulfilled its mission to avert the danger of a much larger war.

Statistics Off the Vietnam Memorial Wall

There are 58,267 names now listed on that polished black wall, including those added in 2010.

The names are arranged in the order in which they were taken from us by date and within each date the names are alphabetized. It is hard to believe it is 36 years since the last casualties.

The first known casualty was Richard B. Fitzgibbon, of North Weymouth, Mass. He is listed by the U.S. Department of Defense as having been killed on June 8, 1956. His name is listed on the Wall with that of his son, Marine Corps Lance Cpl. Richard B. Fitzgibbon III, who was killed on Sept. 7, 1965.

There are three sets of fathers and sons on the Wall. 39,996 on the Wall were just 22 or younger. 8,283 were just 19 years old. The largest age group, 33,103 were



18 years old.
12 soldiers on the Wall were 17 years old.
5 soldiers on the Wall were 16 years old. One soldier, PFC Dan Bullock was 15 years old. 997 soldiers were killed on their first day in Vietnam. 1,448 soldiers were killed on their last day in Vietnam.
31 sets of brothers are on the Wall. Thirty-one sets of parents lost two of their sons. 54 soldiers attended Thomas Edison High School in Philadelphia. I wonder why so many from one school. 8 Women are on the Wall. Nursing the wounded.
244 soldiers were awarded the Medal of Honor during the Vietnam War; 153 of them are

on the Wall. Beallsville, Ohio with a population of 475 lost 6 of her sons. West Virginia had the highest casualty rate per capita in the nation. There are 711 West Virginians on the Wall. The Marines of Morenci - They led some of the scrappiest high school football and basketball teams that the little Arizona copper town of Morenci (pop. 5,058) had ever known and cheered. They enjoyed roaring beer busts. In quieter moments, they rode horses along the Coronado Trail, stalked deer in the Apache National Forest. And in the patriotic camaraderie typical of Morenci's mining families, the nine graduates of Morenci High enlisted as a group in the Marine

Corps. Their service began on Independence Day, 1966. Only 3 returned home. The Buddies of Midvale - LeRoy Tafoya, Jimmy Martinez, Tom Gonzales were all boyhood friends and lived on three consecutive streets in Midvale, Utah on Fifth, Sixth and Seventh avenues. They lived only a few yards apart. They played ball at the adjacent sandlot ball field. And they all went to Vietnam. In a span of 16 dark days in late 1967, all three would be killed. LeRoy was killed on Wednesday, Nov. 22, the fourth anniversary of John F. Kennedy's assassination. Jimmy died less than 24 hours later on Thanksgiving Day. Tom was shot dead assaulting the enemy on Dec. 7, Pearl Harbor

Remembrance Day. The most casualty deaths for a single day was on January 31, 1968 ~ 245 deaths. The most casualty deaths for a single month was May 1968 - 2,415 casualties were incurred. Most Americans who read this will only see the numbers that the Vietnam War created. To those of us who survived the war, and to the families of those who did not, we see the faces, we feel the pain that these numbers created. We are, until we too pass away, haunted with these numbers, because they were our friends, fathers, husbands, wives, sons and daughters. There are no noble wars, just noble warriors.

Living Well Past PTSD

I was fortunate in my assignment in Vietnam, fortunate in the sense of arriving there in 1969, after the Tet Offensive. I was supposed

South Vietnam, and they were extremely important for the North Vietnamese to conquer. One might say that, for the North Vietnamese, the entire success of the Tet Offensive depended on

PTSD is not associated only with these major battles. It can result from all kinds of stress, even for people who were not in battles at all.

So, my purpose in bringing up these facts is to keep into our awareness the importance of seeking support for confronting PTSD challenges. Today there are many different kinds of ways to treat people. Knowledge here is important, such as feeling upset, nightmares, flashbacks, emotional isolation, loss of interest, difficulty in sleeping, and feeling startled.

For me, very helpful was to take part in support groups and realize that others had very similar challenges to the ones I was facing. Realizing this was a turning point for me.

We, Vietnam Veterans, are people who understand PTSD best, but younger troops may not be trained as well. So, the continued support that VVA members provide to younger veterans is important and, no doubt, makes an important difference—actually, an important difference. In conclusion, among all the great things that VVA members do, PTSD support is one of the most important ones. With good knowledge, adequate training, and the crucial support that veterans receive from health providers and other veterans, it is indeed possible to live well in spite of PTSD.

to go in 1968, but because of receiving a direct commission as a second lieutenant in the Signal Corps, my orders to go to Vietnam in February of 1968 were canceled, and I was instructed to receive more training and have one year command experience in the United States, as a platoon leader in an airborne unit.

By 1969, the major battles of the Tet Offensive were over. Mostly, the battles of Quang Tri City and Hue were finished. Those were two provincial capitals in the northern part of

conquering those two cities. The North Vietnamese Army indeed managed complete surprise and even an initial success, but eventually the NVA collapsed. The battle of Hue was especially difficult for the U.S. forces and allies, but after about a month of grinding struggle, the NVA failed.

I have mentioned these facts in connection with PTSD because obviously the troops that were involved in those actions were vulnerable to PTSD, but it is important to keep in mind that
