#### Chaplain's Corner -September 2021

There is a Scripture that explains how the body of Christ works (analogous to the human body). This explanation fits military organizations in general and our VVA Chapter 310 in particular—so



much so that I would like to share it for September. This passage is found in Romans Chapter 12 and reads like this:

I beseech you

therefore,

brethren, by the mercies of God, that you present your bodies a living sacrifice, holy, acceptable unto God, which is your reasonable service. And do not be conformed to this world; but be transformed by the renewing of your mind, that you may prove what is that good, and acceptable, and perfect will of God. For I say, through the grace given to me, to every man (and woman) who is among you, not to think of themselves more highly than they ought to think; but to think soberly, according as

God has dealt to every person the measure of faith.

For as we have many members in one body, and all members have not the same office: so we, being many, are one body in Christ, and every one members one of another. Having then gifts differing according to the grace that is given to us, whether prophecy, let us prophesy according to the proportion of faith; or ministry, let us wait on our ministering; or he that teaches, on teaching; or he that exhorts, on exhortation; he that gives, let him do it with simplicity, he that rules, with diligence; he that shows mercy, with cheerfulness. Let love be without dissimulation. Abhor what is evil; cleave to that which is good. Be kindly affectioned one to another with brotherly love; in honor preferring one another; not slothful in business; fervent in spirit; serving the Lord; rejoicing in hope; patient in tribulation; continuing instant in prayer; distributing to the necessity of saints; given to hospitality. Bless them which persecute you: bless, and curse not. Rejoice with them that do rejoice, and weep with them that weep. Be of the same mind one toward another. Mind not high things, but condescend to men of low estate. Be not wise in your own conceits. Recompense to no man evil for evil. Provide things honest in the sight of all men. If it be possible, as much as lies in you, live peaceably with all men. Dearly beloved, avenge not yourselves, but rather give place unto wrath: for it is written, Vengeance is mine; I will repay, says the Lord. Therefore, if your enemy is hungry, feed him; if he is thirsty, give him drink; for in so doing, you shall heap blessings on

his head. Be not overcome of evil but overcome evil with good. (Romans 12:1-21)

This is sage advice for anytime, but particularly for the time in which we find ourselves with polarity dividing our nation. Let's not allow it to undo our love for, and commitment to, God.

Blessing and honor abounds to you.

#### Legislation Action! H.R. 2568 Vietnam Veterans Liver Fluke Cancer Study Act

The last movement of this bill was on May 29, 2019. This bill was referred to the Subcommittee of Disability Assistance and Memorial Affairs by the Committee on Veterans' Affairs. As of today, there are 17 co-sponsors to this bill. Tim Walberg (R-I7) is the only Michigan US Congressman to co-sign this bill. If you live in another congressional district, please contact your representative to have him or her co-sign this bill. Our AVVA 310 has widows whose Veteran husbands suffered and died from liver cancer. Please consider writing your US Congressional Representative to support this bill in honor and memory of them.

A bill signed into law will allow some veterans with mental health conditions to receive service dogs. A five-year pilot program will provide service dog training to benefit veterans diagnosed with post-traumatic stress disorder. Previously, the VA only covered some costs of service dogs for veterans with certain physical disabilities, such as blindness, hearing impairment, and mobility issues - but not mental health conditions. ## Veterans Honor Guard of Washtenaw County

In the mid-1990s, local Veterans organizations were unable to put together an honor guard unit to provide a good military funeral. And, if they had one, they would generally only do one for their members.

Around 1995, the Ypsilanti
American Legion, led by Jerry
Sims and Tom Ernst, formed up a
group who would do any honorably
discharged Veteran in the area.
We were not all Veterans, but we
did the best we could. We used a
boombox with a cassette recording
of Taps. In the beginning, we might
only get 3 or 4 members out to do
the entire service. And, on cold
winter days, or when the batteries
ran down, the boombox would not
play right. It just froze up some or
played very slowly.



In the beginning, we were an honorable but somewhat ragtag group. We did our best and I believe those we honored looked down and said thank you. Then, things began to improve. We eventually had our own set of rifles and did not have to borrow from different organizations. We established a protocol, uniform design, and started a nice esprit de corps among our group.

In 2000, we were contacted by a local former music teacher, Ralph Harris, who had read about "Bugles Across America." They had written about units like ours needing live buglers. He has been with us ever since and has performed more than 2,000 funerals in our county. Since 2000, we added three other buglers, which makes us a most versatile unit. We also moved the group under the auspices of the VVA Chapter 310, the only county wide Veterans group. We still bring along an electronic bugle, just in case. We also carry a defibrillator to each service, just in case the need arrives.

Our Veteran ranks grew and now today, it is not unusual for us to have 15 Veterans show up to perform military honors. We fire rifles, fold the Flag, present the Flag, and we adopted an educational narrative performed during the Flag folding. It covers



the history and words for Taps and the meaning of the 13 folds in the Flag. This has become a most important aspect of the

service we provide.
During non-Covid years, we average 140-160 funerals per year.
We have been known to cover up to four funerals in one day. These funerals are just in Washtenaw County.

#### Pig Roast Report, 2021

Our 18th Annual Pig Roast was a pork lover's dream! Not only was the pork tender, juicy and flavorful, but it was also generously served, along with delicious sides and cake. The outside serving line moved quickly, manned by four DAR volunteers, two WACU representatives, Chapter and AVVA members and friends, who greeted the hungry customers with a smile, despite the extreme heat and sometimes long shifts before being relieved. The new location was well publicized and drew in about 350 diners, who sat outside under umbrellas or ate inside to escape the heat. Others got their dinners "to go" and enjoyed the delicious meal elsewhere. A few even had their carry-out meals delivered to their cars. During early Pig Roast planning, it was almost impossible to predict Covid-19 restrictions.

The Saline American Legion,

drive-through saurkraut dinners. They welcomed VVA 310 to use their facility since Covid-19 restrictions were apt to limit contact. Also, the construction on Wagner Road near the VFW 423 Post made it a nightmare to try to get to. Fortunately, Covid-19 restrictions opened up, and guests were permitted to go without masks and shorten the "social distance" between friends. The Legion members were equally commited to the event because they sold beer, wine, seltzers, pop, and water. They were a strong force in assembling canopies, tables and chairs. They were on hand during Saturday's start-up of the huge pork roaster that held the 230 pounds of pork butts. To make it tender, the pork was cooked at a low temperature from 11pm Saturday to 12 noon Sunday. At least 5 faithful members took two-hour shifts during the night to prevent the cooker flame from going out. Steve Hitte was the master chef who knew exactly the correct temperature at which to hold the meat to get it to perfection by serving time. Marv Rivers and a Legionnaire did the pork pulling. Things picked up Sunday morning when the sun got high in the sky and people started lining up at the ticket table. There were many compliments about the tasty pork and the delicious cake. One Chapter friend cut all 6 cakes and kept the dessert plates coming. The last dinners were served after 4:15, and only 5 small bags of pork remained, which were sold to those who wanted to have pork again the next day (and it tasted even better!).



# Remembering the Flagpole Raising at Veterans Memorial Park

Over the past several years, there have been at least two attempts to erect a flagpole dedicated to veterans at Veterans Memorial Park in Ann Arbor, Michigan. Between politics and insufficient funds, those attempts were in vain. In June of 2018, then commander of American Legion Post 46 Oleg Michialenko mentioned to fellow member Doug Harvey about how there was no American flag flying at the Memorial Park. Doug followed up by checking with a flag company to see what the price of a forty-foot flagpole, including its installation, would be. They quoted him \$5,000.Doug presented his idea and the price to Legion Post 46, where they approved the project. Doug then approached City of Ann Arbor officials to see if they would let Post 46 have the pole installed at Memorial Park. He was referred to the Parks and Recreation Department, where they arranged a meeting. Several members of Post 46 and the Parks and Recreation met at the proposed site, where the members of the Parks and Recreation looked over the Post's plans. They determined that the plans were a great idea and would be a showcase for Ann Arbor, as the flagpole would be erected in a visible, highly trafficked

area. Several meetings over the following few months with Doug, Oleg, and Parks and Recreation officials took place, and the price tag started to grow. At first, the price tag rose to \$10,000. That seemed manageable, and Legion Post 46 approved the additional funds. Not much later, the price tag rose again, this time to a total of \$20,000, with the addition of landscaping, pavers, and sidewalks. Legion Post 46 decided they still wanted to continue with the project, and they began to fundraise for it. Doug approached Ann Arbor's VFW Post 423 to see if they would contribute to the project. Surprisingly, VFW Post 423 voted to cover the entire remaining \$10,000. On August 9 of 2019, the flagpole was finally erected. It took only three and a half hours from beginning to end. A ceremonial groundbreaking was performed by the members of Legion Post 46, VFW Post 423, and family members. The following day,



about twenty veterans and family members gathered to perform an

informal flag-raising ceremony. The flag was raised, and a prayer and a couple of songs were performed. But the flag had to be lowered that same day, as the lights had not yet been installed. The flag was folded, and photo ops ensued. There was enough pride on that day to last most people a lifetime. Plans are in the works to have a formal dedication ceremony towards the end of September.
