**Minutes** of the November meeting have not yet been published.

# Officer Reports: President's Report:

Several of our members spoke to the students at Saline High School for Veterans Day. We did the Dawn Farm Thanksgiving Dinner. This time we were allowed in the building and were able to see the impact that our dinner has. Thank you to Meijer's for the \$500 gift card we used to buy most of the food. We had a packing party on 4 December and packed 50 boxes. We attended one member's funeral.

#### Treasurer's Report:

Reports were emailed to the Board and to members who wanted one. Let Bourne know your email address. The only major unrestricted activity was the \$500 gift card we received from Meijer's. The Christmas Fundraiser is doing well and is on schedule to meet the budget projection for income. Our budget year ends 28 February. The finance committee has prepared a draft budget that includes \$8.000 that will be used to support veterans. The Board will review and make final revisions to the budget at the January meeting. The budget will be sent out shortly after that so that members may approve a final budget at the February meeting.

#### **AVVA Report:**

Driscoll. Please see report in the Dispatch. Kate Melcher is working with a Marine in hospice. The Marine's family would like a throw for the veteran. Sandy Martinez donated one that Kate picked up tonight. We are going to make two throws for each of the six branches of service over the next year. January, February, and March will be zoom meetings for AVVA. This year we are sending four high school girls to Girls' State.

#### **Committee Reports:**

**Merchandise:** We have 266 Chapter coins for sale and 30 anniversary coins for sale. Both are \$5 each. No other activity this month.

Washtenaw County Council of Veterans: Next meeting will be here. Michigan State Council: We were happy to be able to meet in person again.

Memorial Maintenance: Merritt. Crews are asked to bring their report covers and first two pages to the next meeting so they can be updated. The irrigation plan is complete so we can file our irrigation permit with the Township. The company that gave us the plan for free is also planning to donate

something toward getting the project done and is also working to help us find a sod source and labor force to do the sod work at a discounted rate.

**Website:** McCrumb. We are up around 362,000 hits. We added a new link to some video stories that one of our members created while in the service.

**Membership:** The official number is at 215. We have lost four members so far since Memorial Day. Newsletter: About the time the new computer was ready to work, Paulo Pereira lost his home Internet connection. That is what has caused the delay of the Dispatch this month. It will be out shortly. **Healthcare:** The choice program that lets you go to a civilian facility if you can't use a VA facility in a reasonable time is consuming 1% of the VA's total budget. As a result, the program will see some substantial changes soon.

There's a new research report out that says the Gulf War Syndrome was caused by the destruction of sarin gas weapons. It has also been determined that the insecticide Dursban causes the same problems as burning sarin gas, and that Dursban was used extensively by the military.

VVA has hired a new person to advise the Board on health issues. LTCCSKMC: Kinzinger. Jane gave the report. If you remember, we buy shirts every year that we take to Linda Colby who then embroiders them especially for the VA patients. This year, 10 people who have already been identified will be allowed to go into the VA to deliver those embroidered shirts. We also spend thousands of dollars for underwear for the VA patients, which we delivered to voluntary services

already. They will hand those out for us.

Old Business: None

New Business: Motion by Rivers, seconded by Clarke to amend Article VI Section 1 to reduce the Board size from 10 directors to 6 by eliminating 2 two-year members and 2 one-year members.

The amended section would then read:

"Section 1 – Board Composition
The officers and six directors shall
constitute the Board of Directors.
Three of the directors shall be
elected annually to serve a term of
two years or until their successors
are elected. In this way, the Board
of Directors will maintain three
members with two years and three
members with one year remaining
in their term of office."

The motion was approved.

**Motion** by Rivers, seconded by Clarke to donate \$200 toward the purchase of a \$553 dollar lift chair for a member with cancer.

Motion by Clarke, seconded by Bull, to amend the motion to state that the donation will come from the support for hospitalized patients restricted fund. The amendment was approved.

The amended motion was approved.

#### Good of the Order:

**McCrumb:** Dr. Reuel Long wrote a book about his experiences in Vietnam. He has copies for sale at the meeting.

**Driscoll:** Cindi is having a skin graft at the end of the month.

McCrumb: I ordered a black T-shirt with our logo and my name. If you want one for yourself, it will cost \$19 plus shipping. Just let me know, and I'll help you order it from https://www.stickermule.com/studio.

**Draper:** Steve Duncan is faced with multiple medical issues that are getting worse. He needs your prayers.

**Bull:** We are doing a project called Reverse Advent to help local food banks replenish their food supplies. We ask that you take home one of the bankers boxes in the lobby. Then use the reverse advent calendar (also in the lobby) to remind you to place one nonperishable food item in the box each day. Once the box is full, contact me. **Bull:** We must deliver our Toys for Tots collection to the Marine Corps by the 20th, so please stop by Wednesday or Saturday when we are here to drop off your toys to us by the 17th.

**Bull:** Moose Lodge donated 30 cold-weather coats with scarves and gloves for the Resource Center.

Wilson: The 40th anniversary of the Vietnam Veteran's Memorial Wall went very well. The Secretary of Defense and the Secretary of the VA were both there. We reviewed the PACT Act to see what was added and to figure out who will benefit from it. There was also a big reception.

Wilson: Getting things through Congress is going to be even more difficult than in the past. The pressure is on now more than before to do the Agent Orange Townhall meetings again. We need to explain the PACT Act and current knowledge about toxins in military service.

Wilson: With changes in PACT Act and Blue Water bill, the Washtenaw County Department of Veterans Affairs, now under the supervision of Acting Director David Saims, has 2,000 claims that can now be resubmitted. If you want your claim

resubmitted, please let the office know right away.

Cothorn: At her request, we had a short discussion of SB 783 and 784, which take away the disabled veteran's property tax relief and replace it with a sham in the form of a state income tax credit that almost nobody will qualify for. The bill was introduced by Jon Bumstead, from District 34. Suddenly, this bill is gaining traction. It was approved in the Senate and sent to the House, where the House approved a revised version that was sent back to the Senate on 7 December this year. Now is the time to let your legislators know what you think of their dog-and-pony show.

**St. Antoine:** I really needed your recent prayers, especially this weekend. Thank you very much for them. They helped a lot.

# Honoring January Anniversaries on the Wall

Private First Class Walter Edwin McIntire, Jr. was born on October 2, 1943 in Laredo, Texas to Mr. and Mrs. Walter E. McIntire of Ann Arbor, Michigan. Walter graduated in January of 1964 from Ann Arbor High School where he was active in Junior Achievement and was the Vice-President of his JA company. He was also active in the Cooperative Occupational Training Program at Ann Arbor High School and



worked part-time for S. S. Kresge Company.

Private First Class Walter Edwin McIntire, Jr. began his tour of duty in Hau Nghia Province, South Vietnam on August 21, 1965 serving as an infantryman with B Company, 2nd Battalion, 503rd Infantry, 173rd Airborne Brigade. On September 18, 1965, Walter earned a Purple Heart when he was wounded by shrapnel in his leg. He recovered from those wounds and returned to his unit four weeks later. On January 2, 1966, Walter was killed by small arms fire in action near the Bien Hoa Air Base.

Walter Edwin McIntire, Jr. is survived by his parents, three brothers and two sisters. He lived 22 years and 3 months. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Walter's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 04E Line 051.

Warrant Officer John David Eddy was born on March 1, 1950 to Mr. and Mrs. Delvord Eddy of Ann Arbor, Michigan. John is a 1968 graduate of Pioneer High School in Ann Arbor. He loved team sports, the out-of-doors, and camping trips to Lake Huron when he was young. John's ambition was to fly. Warrant Officer Eddy enlisted in the Army in 1970. He completed helicopter flight training at Fort Wolters, Texas. He went through advanced flight training at Fort Rucker. Alabama.

Warrant Officer John David Eddy began his tour in An Xugen Province, South Vietnam on June 16,



1971. John was the copilot of a helicopter gunship when it was struck by enemy gunfire and crashed. Warrant Officer Eddy died with three of crew members on January 11, 1972. Warrant Officer John David Eddy earned the Air Medal for heroism, the Bronze Star Medal, the Purple Heart, National Defense and Vietnam Service Medals and the Republic of Vietnam Campaign

Medal. The South Vietnamese Government presented him with the Military Merit Medal and Gallantry Cross with Palm.


John David Eddy is survived by his parents, a wife, two daughters and a son, and two sisters. He lived 21 years, 10 months and 10 days. His name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. He is also listed on the Vietnam Memorial in Washington, DC on Panel 02W Line 096.

Warrant Officer Michael Woodrow

**Hunter** was born on January 23, 1944 in Durham, North Carolina to Mr. and Mrs. Woodrow W. Hunter of Ann Arbor, Michigan. Michael is a 1962 graduate of Ann Arbor High School. He also attended Western Michigan University.

Warrant Officer Hunter entered the Army in 1967 going through Basic Training at Fort Benning, Georgia. He was trained as a paratrooper and a helicopter pilot. Michael received his Wings as an Army Aviator in April of 1968 graduat-



ing tenth in his class. He began his tour of duty in Phuoc Long Province, South Vietnam on July 14, 1969 serving as a helicopter co-pilot on an AH-1G with C Troop, First Squadron, Ninth Cavalry, First Air Cavalry Division. Michael was killed on January 28, 1970 when the helicopter he was co-piloting was struck by enemy anti-aircraft fire during a gun run. The aircraft was struck by a 50-cal. round causing the main rotor to separate. He received the Silver Star, Purple Heart and Air Medal.

Michael Woodrow Hunter is survived by his parents, two sisters, and his son. He lived 26 years and 5 days. He is resting in the Swedish Mission Cemetery located in Centerville Township, Leelanau County, Michigan. Michael's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 14W Line 075.


Major George Frederick Vlisides was born on December 31, 1924 in Detroit, Michigan to Mrs. Elena



Vlisides of Ann Arbor, Michigan. George is a 1943 graduate of Ann Arbor High School. George enlisted in the Army Air Corps, and received his Second Lieutenant's commission and Bombadier Wings in 1944. He flew heavy bombers, but never made it overseas. He graduated from the Military Academy at West Point near the top of his class in 1950 where his classmates called him "Gorgeous One." George enlisted in the Air Force after graduation from West Point. He earned a Distinguished Flying Cross, the Bronze Star Medal and the Air Medal with two clusters flying 84 missions in the F-84 during the Korean War. He graduated from the Air Command and Staff College in 1961.

Major Vlisides began his tour of duty in Bien Hoa Province, South Vietnam on November 5, 1964 serving with the 1st Air Commando Squadron, 34th Tactical Group, 13th Air Force. George earned another Air Medal in Vietnam. He also was shot down twice with the last time occurring on December 29, 1964. He celebrated his 40th Birthday on December 31, 1964. George died on January 27, 1965 when his A-1E Skyraider crashed in a landing attempt at Bien Hoa Airfield. He earned another Distinguished Flying Cross and two more Air Medals during his tour. George Frederick Vlisides is survived by his mother, a brother and a sister. He lived 40 years and 26 days. He is resting in the Greek Orthodox Cemetery in Ann Arbor, Michigan. George's name is listed on the Vietnam Memorial in Ypsilanti Township under Ann Arbor. His name also appears on the Vietnam Memorial in Washington, DC on Panel 01E Line 084.

Corporal Eddie Wallace was born on January 12, 1949 in Birmingham, Alabama to Mr. and Mrs. Wesley Lee of Ypsilanti, Michigan. Eddie graduated from Ypsilanti High School in 1968. He worked



for Gar Wood Industries before enlisting in the Army in 1968. Corporal Wallace began his tour of duty in Phong Dinh Province, South Vietnam on December 20, 1968 serving as a Petroleum Supply Specialist with the 271st Assault Support Helicopter Company, 307th Aviation Battalion, 164th Aviation Group, 1st Aviation Brigade. Eddie was killed on January 13, 1969 when a hand grenade was thrown at him while he was on guard duty. Eddie had been "In-Country" for only 23 days.

Eddie Wallace is survived by his parents, four brothers and a sister. He lived 20 years and 1 day. Eddie is resting in Westlawn Cemetery in Inkster, Michigan. Eddie's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilan-

ti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 35W Line 086.

Private First Class Michael Dean Cribelar was born on June 27, 1949 to Mr. Woodrow Dean Cribelar and Mrs. Virginia Cribelar. Michael attended Willow Run High



School in Ypsilanti, Michigan. He worked for Ford Motor Company at the Ypsilanti Plant prior to entering the Army on June 9, 1967. Private First Class Cribelar completed Basic Training at Fort Knox, Kentucky. He began his tour of duty in Pleiku Province, South Vietnam as an infantryman with B Company, 2nd Battalion, 8th Infantry, 4th Infantry Division on November 22, 1967. Michael was killed on January 11, 1968 from small arms fire after being "In-Country" for one month and eleven days. Michael Dean Cribelar is survived

by his parents, his wife and twoyear-old son, and two sisters. He lived 18 years, 6 months and 14 days. He is resting in Washtenong Memorial Park in Ann Arbor, Michigan. Michael's name is listed on the Vietnam Memorial in Ypsilanti Township under Ypsilanti. His name also appears on the Vietnam Memorial in Washington, DC on Panel 34E Line 028.

Private First Class Larry Gene Gray was born on March 19, 1945 in Missouri to Mr. and Mrs. Robert Gray. Larry is a 1963 graduate of Dundee High School located in Dundee, Michigan.

Private First Class Gray entered the Army on July 18, 1966 receiving his Basic Training and Cook's School at Fort Knox, Kentucky.
Larry began his tour of duty in Hau Nghia Province, South Vietnam on January 5, 1967 serving as a Food Service Specialist with Headquarters, Headquarters Company, 1st Battalion, 5th Infantry, 25th Infantry Division. He was killed on January 17, 1967 when the helicopter he was riding on during a combat support mission disintegrated in flight. He was "In-Country" for only



12 days.

Larry Gene Gray is survived by his wife, his parents, a brother and three sisters. He lived 21 years, 9 months and 28 days. He is resting in the London Township Cemetery located near Milan, Michigan. Larry's name is listed on the Vietnam Memorial in Ypsilanti Township under Milan. His name also appears on the Vietnam Memorial in Washington, DC on Panel 14E Line 044.

## **On Paul Dumsch**

[A note: This is Poem #6 in the series of writings by deceased past Chapter President Paul S. Dumsch. His Army service in Vietnam caused Paul's struggle with PTSD. His writings reflect some of that.]

#### Dad

I came to visit.
It was a snowy,
Winter day.
I wiped a dozen
Of the flat stones clean
But I couldn't find you.
